**To Garden City Office:** From the Meadowbrook Parkway, take Old Country Road West @ 2 mi.; make Left onto Franklin Ave.; Go thru 2 Traffic Lights (stop if they're red!); then make Left onto 13<sup>th</sup> Street (across from Lord & Taylor) ; Building facing you is the Merrill Lynch Building.

**To Melville Office:** Take LIE East to Exit 49South; Take South Service Road to first Traffic Light; Make Left at Light; Go thru 1 Traffic Light (stop if it's red!); make Left into Parking Lot (across from Marriott Hotel)
